### **CALL TO ORDER:**

Chairman Bechtel called the meeting to order at 7:00 p.m. followed by the Pledge of Allegiance.

# **ROLL CALL:**

Supervisors Bechtel, Paul, Schreffler, and McBurney were present along with Solicitor Warshawsky, HRG, Inc. Alex Greenly, Roadmaster Matt Roland, and Secretary Sara Glace. Supervisor Bruner was absent.

#### **RECORDING MEETING:**

Halifax Township secretary is the only person reportedly recording the meeting.

### **EXECUTIVE SESSION:**

There were no executive sessions held in the last month.

# **PUBLIC COMMENT PERIOD:**

No person spoke under public comment.

### SECRETARY/TREASURER REPORT:

<u>Paid Interim Bills:</u> A **Motion** was made by Supervisor McBurney and seconded by Supervisor Paul to approve the paid bills through October 14<sup>th</sup>, 2024. Vote called. **Motion** carries 4-0.

<u>Current Unpaid Bills:</u> A Motion was made by Supervisors Schreffler and seconded by Supervisor Paul to approve the unpaid bills through October 14<sup>th</sup>, 2024. Vote called. **Motion** carries 4-0.

# **Meeting Minutes:**

September 9<sup>th</sup>, 2024, Regular Meeting Minutes: A Motion was made by Supervisor McBurney and seconded by Supervisor Paul to approve the September 9<sup>th</sup>, 2024, Regular Meeting Minutes. Vote called. Motion carries 3-0-1. The abstention vote was Supervisor Schreffler as he was not present at the September 9<sup>th</sup>, 2024, Regular Meeting.

### **EMC REPORT:**

Chief Tim Neiter was not present but did submit a report for September 2024.

# PLANNING COMMISSION RECOMMENDATION:

A report was submitted for the Planning Commission meeting that was held on Monday, October 7<sup>th</sup>, 2024. Chairman Bechtel advised that the Planning Commission continued discussing Small Project Provisions to Stormwater Management, Hale Land Development requested a Time Extension, and Halifax Township submitted a Subdivision for Fort Halifax.

<u>Hale Time Extension:</u> A **Motion** was made by Supervisor Paul and seconded by Supervisor Schreffler to approve the Hale Time Extension from August 29<sup>th</sup>, 2024, to January 13<sup>th</sup>, 2025. Vote called. **Motion** carries 4-0.

<u>Fort Halifax:</u> A Motion was made by Supervisor Schreffler and seconded by Supervisor Paul to grant the four waivers for the Fort Halifax Plan, which are: Section 404: Preliminary Plat Procedure, Section 407.1X: E&S Plan, Section 505.3a: Min. Lot Width and Max. Lot Coverage, and Section 602: Monuments & Markers. Vote called. Motion carries 4-0. A Motion was made by Supervisor Schreffler and Supervisor Paul to give conditional approval for the Fort Halifax Plan. Vote called. Motion carries 4-0.

### **ENGINEER REPORT:**

HRG, Inc. Engineer Alex Greenly was present to cover his report dated October 11<sup>th</sup>, 2024, on services that occurred during the month of September 2024.

Bechtel Farms-212 Parmer Drive: A Motion was made by Supervisor Paul and seconded by Supervisor Schreffler to release \$13,235.00 in financial security to Bechtel Farms in full. Vote called. Motion carries 3-0-1. The abstention vote was Chairman Bechtel

<u>Robert Terry Pole Barn SWM:</u> A Motion was made by Supervisor McBurney and seconded by Supervisor Paul to release \$6,491.00 in financial security to Robert Terry in full. Vote called. **Motion** carries 4-0.

#### SOLICITOR REPORT:

Solicitor Warshawsky submitted his report dated October 8<sup>th</sup>, 2024, on services during September. The report will be placed on record. Bold text items are on the agenda.

### **ROADMASTER REPORT:**

A report was submitted for September 2024 by Matt Roland, Ryan Malone, and Colton Warfel. Roadmaster Matt Roland advised that Tobias and Shammos School Road were regraded, and material was added, Seiders Road material was added for shoulder backing, one-third of the bamboo was removed from behind the Lamb property and fall road mowing has started throughout the township.

Vicki Vitolo, member of the Friends of Fort Halifax, was present and submitted a report for September 2024. Vicki Vitolo, spoke to the Board of Supervisors about the Decker family to honor Michael Decker with building a memorial deck with the help of Dauphin County Technical School building trades program and the Eagle Scout fence around the herb garden to earn an Eagle Scout Award.

<u>2024 Volunteer Fire Relief Money:</u> A **Motion** was made by Supervisor Schreffler and seconded by Supervisor McBurney to donate \$21,563.36 to the Halifax Fire Department. Vote called. **Motion** carries 4-0.

2025 Estimated Liquid Fuels Money: The 2025 Estimated Liquid Fuels Money is \$182,397.25.

Advertisement of Wash Bay & Pole Building: A Motion was made by Supervisor Paul and seconded by Supervisor McBurney to approve the advertisement of the Wash Bay and the Pole Building. Vote called. Motion carries 4-0.

<u>Cyber Security & ADA Compliant:</u> It was advised that Cyber Security Insurance was not needed here in Halifax Township. Halifax Township is working with Travis Enders to have the website ADA Compliant by April 26<sup>th</sup>, 2027.

EMS Tax: Questions were brought up that required additional research by Solicitor Warshawsky.

2025 Contribution Rate for PSATS UC Group Trust: The 2025 Contribution Rate for PSATS UC Group Trust is 0.90%.

<u>Upper Dauphin EMS Focus Group:</u> Supervisor Schreffler volunteered to attend the Upper Dauphin EMS Focus Group to be held on Tuesday, October 22<sup>nd</sup>, 2024, or Wednesday, October 23<sup>rd</sup>, 2024.

North River Road Speed Limit: Sean Bob, who lives at the end of Tourist Park Road that meets with State Route 147. He requested that Halifax Township write a letter to PennDOT requesting a reduction in the speed limit from 55 mph to 45 mph. A Motion was made by Supervisor Schreffler and seconded by Supervisor McBurney to approve the request to write PennDOT a letter requesting a reduction in the speed limit from 55 mph to 45 mph. Vote called. Motion carries 4-0.
