## HALIFAX TOWNSHIP DAUPHIN COUNTY, PENNSYLVANIA RESOLUTION # 16-\$\sum\_{-2016}\$

A RESOLUTION OF THE BOARD OF SUPERVISORS OF HALIFAX TOWNSHIP, DAUPHIN COUNTY, PENNSYLVANIA AUTHORIZING THE EXTENSION OF WORKERS' COMPENSATION INSURANCE COVERAGE FOR FIRE DEPARTMENT VOLUNTEERS TO ACTS WHICH OCCUR OUTSIDE OF HALIFAX TOWNSHIP

WHEREAS, Halifax Township is a Township of the Second Class in the County of Dauphin, Commonwealth of Pennsylvania,

AND WHEREAS, pursuant to the Second Class Township Code, 53 Pa.C.S. 67803 may appropriate monies for Fire Companies (Departments) within the Township;

AND WHEREAS, Halifax Township has historically paid for the entirety of the Halifax Fire Department (located within the Township) Workers' Compensation insurance premiums for Department volunteers and continues to do so for the calendar year 2016;

**AND WHEREAS**, a question has arisen about whether the Workers' Compensation insurance coverage for such volunteers extends beyond the jurisdictional borders of Halifax Township;

AND WHEREAS, by Motion on February 8, 2016, the Board of Supervisors of Halifax Township authorized the extension of such Workers' Compensation insurance coverage beyond the jurisdictional borders of Halifax Township so that the Halifax Fire Department may efficiently and effectively discharge its duties to the general public;

AND WHEREAS, the Halifax Township Board of Supervisors desires to make such decision a Resolution to govern any future Workers' Compensation coverage for Halifax Fire Department volunteers for acts which occur beyond the jurisdictional borders of Halifax Township.

**NOW, THEREFORE BE IT RESOLVED**, by the Board of Supervisors of Halifax Township, Dauphin County, Pennsylvania as follows:

**NOW THEREFORE**, it is hereby resolved by the Board of Supervisors of Halifax Township, Dauphin County, Pennsylvania that any Workers' Compensation coverage purchased by Halifax Township for the Halifax Fire Department volunteers shall extend to the operations and acts by them which occur beyond the jurisdictional borders of Halifax Township which properly implicate such Workers' Compensation insurance coverage.

THE FOREGOING RESOLUTION was adopted by the Board of Supervisors of Halifax Township, Dauphin County, Pennsylvania on the 14th day of 1900 and 2016.
