RESOLUTION # 10-8-2010**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF HALIFAX  
TOWNSHIP, DAUPHIN COUNTY, PENNSYLVANIA ESTABLISHING  
ASSESSMENT RATES, WAIVING OCCUPATION TAX AND SETTING  
THE MILLAGE RATE FOR MUNICIPAL REAL ESTATE AND FIRE  
PROTECTION FOR THE CALENDAR YEAR 2011.**

**WHEREAS**, the Board of Supervisors of Halifax Township, Dauphin County, Pennsylvania, is required to set certain tax and assessment rates pursuant to the various enabling statutes of the Commonwealth of Pennsylvania; AND

**WHEREAS**, the tax and assessment rates are unchanged from calendar year 2010, thus neither re-enactment of the various taxes and assessment nor advertisement of this resolution pursuant to 53 P.S. §6904 is required.

**NOW THEREFORE BE IT RESOLVED**, by the Board of Supervisors of Halifax Township, Dauphin County, Pennsylvania the electric street light illumination assessment levied on certain real estate portions of roadway situated within Halifax Township, Dauphin County, Pennsylvania be set as follows for the calendar year 2011: Class I \$.104, Class II \$.13, class III \$.416, Class IV \$.52, Class V \$.117 and Class VI \$.468 per every foot of frontage associated with a given parcel.

**ALSO BE IT RESOLVED**, that the tax imposed on (1) REAL ESTATE be set at .42 mills and (2) for the privilege of engaging in an occupation within the Township of Halifax be waived for the calendar year 2011.

**ALSO BE IT RESOLVED**, that the (1) Per Capita tax be set at \$5.00; (2) Earned Income tax be set at .5 percent; (3) Fire Protection tax be set at .51 mills; and (4) Real Estate transfer tax be set at .5 percent for the calendar year 2011.

**ALSO BE IT RESOLVED**, that Halifax Township hereby designates H.A. Berkheimer, Inc. to exclusively collect the Earned Income Tax levied by Halifax Township for the term commencing January 1, 2011 and ending December 31, 2011, subject to the successful negotiation of a binding contract between Halifax Township and H.A. Berkheimer, Inc.

**AND BE IT FURTHER RESOLVED** that this resolution shall be effective January 1, 2011.

**THE FOREGOING RESOLUTION** was adopted by the Board of Supervisors of Halifax Township, Dauphin County, Pennsylvania on December 13, 2010.
