A RESOLUTION OF THE BOARD OF SUPERVISORS OF HALIFAX TOWNSHIP, DAUPHIN COUNTY, PENNSYLVANIA AUTHORIZING THE INTERMUNICIPAL TRANSFER OF A LIQUOR LICENSE TO HALIFAX TOWNSHIP

WHEREAS, Halifax Township is a Township of the Second Class in the County of Dauphin, Commonwealth of Pennsylvania, and

WHEREAS, it is the responsibility of the Board of Supervisors of Halifax Township to improve the public health, safety and welfare within the Township; and

WHEREAS, Halifax Township received a request for the intermunicipal transfer of Pennsylvania Liquor License R-20918, LID 21181 "License"; and

WHEREAS, The License is currently owned by Dennis F. Bisking, and the License is currently issued for real property located at 3776A Powells Valley Road (Mailing Address RD2 Box 494), Wayne Township, Dauphin County, PA 17032; and

WHEREAS, The approval for an intermunicipal transfer is a condition of a proposed transfer of the License to Doughboys Pizzeria 2, LLC, the applicant of the request, to operate under the License at 3652A Peters Mountain Road, Halifax Township, Dauphin County, PA 17032-9504; and

WHEREAS, The Pennsylvania Liquor Law, 47 P.S. § 4-461 requires Halifax Township to hold a public hearing for the purpose of receiving comments and recommendations of interested individuals residing within Halifax Township concerning the applicant's intent to transfer the License into Halifax Township; and

WHEREAS, Halifax Township lawfully advertised and held a public hearing on the application and request to transfer the License to Halifax Township, Dauphin County as the receiving municipality, on Monday, April 13, 2015 at 6:45 p.m. at the Halifax Township Municipal Building located at 102 Fisher Street, Halifax Township, Dauphin County, PA 17032 (the "Public Hearing"); and

NOW, THEREFORE BE IT RESOLVED, by the Board of Supervisors of Halifax Township, Dauphin County, Pennsylvania as follows:

After receiving testimony and comments at the Public Hearing from the applicant and interested members of the public, Halifax Township hereby resolves to approve the request for the intermunicipal transfer of the License to Halifax Township by unanimous vote upon motion by Supervisor Paul, seconded by Supervisor McBurney.
